Thank you for your email. I note what you say.

The role of the police is quite clear: they must enable peaceful protests to take place; they must enable workers to go about their lawful business; they must keep law and order.

Having seen many video clips and also having been to see for myself, I would caution against drawing too many conclusions from any one. Things are not always as they seem and I have people giving me very different accounts. For that reason I have asked my Advisory Policing Protests Panel to observe and report. They are neutral observers.

But the main point is that this is a dispute between Sheffield City Council and some of its residents with the police in the middle. It needs a political solution.
